**Program: Master of Science in Administration of Justice** 

The Master's program in Administration of Justice was introduced in fall 2007. The mission of the Master of Science in Administration of Justice is to educate a cadre of justice academicians and professionals as change agents prepared to teach, conduct research and assume administrative and policy positions at all levels of government and in the private sector both nationally and globally. In addition, the program prepares and encourages students to pursue a doctoral degree in the field of administration of justice, criminal justice, and criminology as future scholars, researchers, and faculties in the discipline. The first cohort of students for the Master's program in Administration of Justice enrolled in fall semester 2007.

#### Goal 1

The goals of the program are to provide students with knowledge of the discipline and theories of administration of justice; and knowledge and skills in research and statistics needed for careers in administration of justice including research and teaching, or to pursue a doctoral degree.

# Outcome 1.1 – Students will demonstrate knowledge of administration of justice that includes the history and theory of the discipline

# Findings (2009-2010)

The metric for assessing these outcomes was the Capstone course, encompassing the key elements of theory and research methods and statistics. Because of the relative newness of the MS program, the Capstone course was offered and assessed for the first time in the 2009-2010 academic year. All 8 (100%) of the examinees passed both elements of the Capstone course and thus exceeded the target of eighty percent.

# Action Plan Summary - 2009-2010

To maintain the same level performance, the program will continue to monitor teaching and learning provisions and delivery.

### Outcome 1.2 – Apply methodological and statistical knowledge in justice agency administration

## Findings (2009-2010)
