All candidate teachers are required to enroll in two Instructional Technology courses. Included in the courses are activities that teach: how to utilize the computer in instruction, e.g. the Smart board, to collect and analyze data, to access web sites particularly geared to instructional tools, e.g. rubrics, and to access web sites that provide opportunities for EC-12 students to learn. Many classes, including clinical practice, require candidate teachers to develop electronic portfolios. The principles of universal design for learning are included in special education coursework, including those courses in which general educators are enrolled. In using technology to manage data and analyze data, candidate teachers are required to conduct an "Action Research" project and present the study, including their hypothesis, data collection methods, experimental design, results, and recommendations for further study. All candidates prepare presentations for their peers in clinical practice.
