3 - \$2,500 Scholarships Available for Undergraduate and Graduate Students for the Spring 2023 Semester

Scholarship Information:

The Jesse H. Jones School of Business is pleased to present the prestigious and highly competitive Kase and Eileen Lawal Endowed Scholarship opportunity to business students with an interest in international business and global trade. **The scholarship is matched by the President's Leadership Scholarship (PLS), allowing scholarship recipients to receive a \$2,500 Lawal award, in addition to a \$1,000 PLS award.** Scholarship review will occur in the Fall 2022 Semester and awards will be distributed to recipients' TSU student accounts in the Spring 2023 Semester. The scholarship is renewable.

Scholarship Eligibility Criteria:

- Must be enrolled full-time undergraduate students (minimum of 12 semester credit hours) and graduate students (minimum of 9 semester credit hours)
- Must be an undergraduate majors in accounting, finance, management, MIS, marketing, or graduate student
- MBA and M.S. in MIS students must have unconditional admission status
- Must be classified as a junior, senior, or graduate students in good standing, including transfer credits
- Must have achieved an overall grade point average of 3.5 or better
- Must have completed the Free Application for Federal Student Aid (FAFSA) online or completed and filed the Texas Application for State Financial Aid (TASFA) form (for Non-U.S. Citizens/Texas residents) with the Office of Financial Aid, as required of all scholarship recipients by the University.

Scholarship Application Requirements:

- □ Demonstrated coursework Official transcript from all colleges/universities attended (transcripts must be in a sealed envelope from the registrar)
- □ Short essay (500 words, double-spaced) describing your interest in international business and global trade as a career focus
- **One letter of recommendation from a current or recent professor, student affairs staff, or employer**
- Professional Resume'
- □ Professional headshot (color) in business attire

Kase and Eileen Lawal Scholarships are awarded without regard to race, sex, age, national origin, or sexual orientation.

The scholarship award will be used to cover tuition, fees, and related costs.
