Thurgood Marshall School of Law recently captured the ***Regional Championship at the National Trial Competition (NTC)*** — the nation's oldest and most prestigious law school mock trial competition. Widely regarded as one of the most rigorous advocacy tournaments in the country, NTC requires competitors to prepare a randomly assigned witness just **15 minutes before trial**, testing both preparation and courtroom agility.

This year's regional tournament featured 18 two-person teams representing law schools from Texas, Louisiana, and Kansas. Representing TMSL, **Destiny Rodriguez (3L)** and **DeAndre Bell II (3L)** delivered an outstanding performance, going undefeated throughout the competition. Their victory marks TMSL's **first NTC regional championship in over a decade**.

The win secures TMSL a bid to compete in the 30-team National Tournament this April in Dallas, placing the school among the top trial advocacy programs in the country.

The team was directed by **Tim Adams**, coached by **Daniel Franco** and **Antonelly Vargas**, with additional support from **Sheridan Davis (3L)** and **DaMazia Gaines (2L)**, who served as practice partners and witnesses throughout the tournament. The program also benefited from the mentorship and countless volunteer hours of **Attorney Spogmay Khalid**.

This achievement reflects the continued strength and excellence of TMSL's advocacy program on the regional and national stage.
