Legal Research Crash Course

The Crash Course In Legal Research otherwise known as “Legal Research Boot Camp” was held online via Zoom this year on Saturday, March 28, 2026. Our Academic Representatives from Lexis and Westlaw, Adriana Ramirez (Lexis) and Aden Luckett (Westlaw) did a wonderful job preparing students for internships! They identified things you need to know while using their products as a Summer Associate and demonstrated a search from the provided fact pattern. They also highlighted popular AI tools while clarifying how they use extractive AI which utilizes only verified sources within their search engines. For practical application, the students researched a Wills/ Probate fact pattern. Afterwards, the participants received extra credit for Legal Research, Lexis points and other goodies from Westlaw! Through this significant experience, the research assistants will leave the program being more proficient legal researchers and writers, preparing them for success in future classwork, interviews, and jobs!

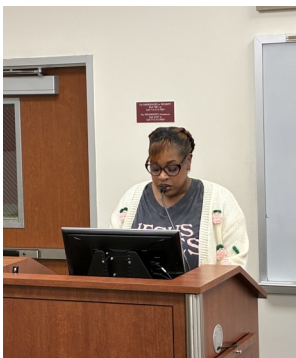


DeCarlous Spearman Poetry Contest Open Mic Night

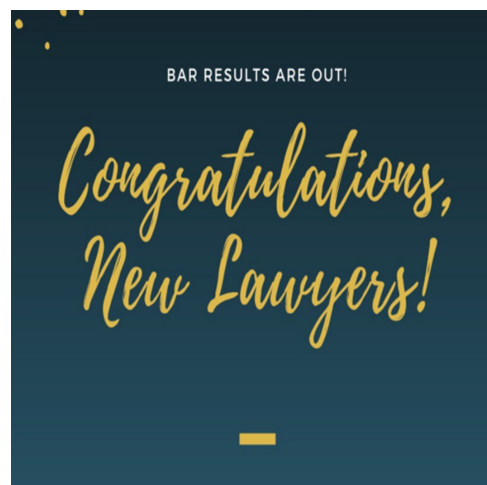
