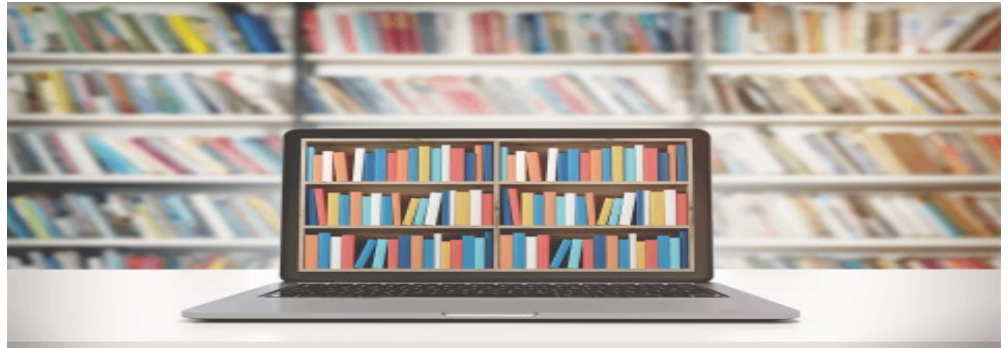

Black History Month 2026 I AM BLACK HISTORY

Associate Justice Henry Eman Doyle **Thurgood Marshall School of Law 1950**

HENRY EMAN DOYLE was born March 15, 1910 in Austin, Texas. He received his Bachelors Degree from Samuel Huston College and taught in the Austin public school system. He did graduate study at Columbia University. Thereafter, he enrolled in Texas Southern University's School of Law and became its first graduate in 1950, having previously been admitted to the Texas State Bar in 1949.

Judge Doyle had a long and distinguished career in the legal profession, including service as legal counsel for the Houston Chapter of the NAACP. In 1977 Judge Doyle was appointed to the bench of Houston Municipal Court No.6. On December 1, 1978 he was appointed as an Associate justice of the First Court of Appeals of Texas. He retired from the bench on December 31, 1984.

In commemoration of Black History Month, Thurgood Marshall Law pays tribute to a distinguished man of firsts:

ASSOCIATE JUSTICE HENRY EMAN DOYLE

(March 15, 1910 – March 2, 1985)

- ★ FIRST and Only Graduate of Thurgood Marshall School of Law '50
- ★ FIRST African American to graduate from a Texas law school and pass the bar exam in '49
- ★ FIRST African American Associate Justice of a Texas Court of Appeals (1978-1984)
